

Madeleine Korbel Albright: A Legacy of Death, Deracination and Deceit

Perhaps the most telling connection in the history of Madeleine Albright is that to premier diamonds merchant Maurice Templesman. A frequent deep-pocketed contributor to the Democratic Party, Templesman is also deeply connected to the Central Intelligence Agency. Little is known about him, and his dealings or activities are never reported beyond the social pages of the media.

Templesman is believed to have been deeply in-the-know regarding the assassination of Patrice Lumumba and the politics of deconstruction and dictatorship in Congo/Zaire. From the coup that placed Mobutu in power, and throughout the Mobutu era, Maurice Templesman maintained very intimate ties with Mobutu, and he remained deeply entrenched with Lawrence Devlin, CIA Chief of Station in Zaire, who worked for Templesman for some 15 years after leaving the CIA (circa 1973), to about 1987.

Connected with the Kennedy Administration, Templesman is a known associate of Robert S. McNamara, former Secretary of Defense under Kennedy. Templesman retained deep ties to the Kennedys, and he is the former lover of Jacqueline Onassis, whom he shared an apartment with in Manhattan, and with whom he often sailed -- joining the Clinton's off Martha's Vineyard before his lover, Onassis, died of cancer (1994).

Templesman formed an intimate and romantic relationship with Madeleine Albright in the mid 1990's. However, his affiliations with Albright are varied and unique, and he appears either principally or peripherally through most of the institutions she has been a part of. These include: the Center for National Policy; Clinton's Interagency Council on Women (tie to Robert S. McNamara); through the National Democratic Institute for International Affairs; and through the Corporate Council on Africa.

Through his companies, Leon Templesman & Son, and Lazare Kaplan International, and with the support of private military companies, Templesman continues to strike up lucrative diamond deals with (other) warmongers, warlords and organized criminals. The prominent diamonds that Madeleine Albright adorns herself with are almost certainly the spoils of Maurice Templesman's genocidal profiteering in Africa.

Rejecting the legitimizing terminologies of statecraft, peacekeeping, foreign policy and international affairs, the legacy of Madeleine Albright might best be summed up in terms of duplicitous public statements backed by Orwellian double-dealing in a private world beset by corruption, vested interests and organized crime.

Detailed Biographical Info:

➤ **1970's: Columbia grad student under Zbigniew Brzezinski**

As Dr. Ed Ferguson so aptly articulated it, Madeleine Albright adheres to a blueprint for empire formulated by and under the tutelage of cold-war ideologue Zbigniew Brzezinski, National Security Advisor to President Carter (1977-1981), a professor at the Rockefeller-funded Russian Research Institute at Columbia University, a member of the Trilateral Commission and the Council on Foreign Relations.

➤ **1978-1981: joined National Security Council (NSC)**

The NSC has played a major role in institutionalizing terror through covert actions: coups, repression, assassinations, massacres, poverty and fear -- integral factors of the national security state.

➤ **mid-1980's: Senior Fellow Center for Strategic and International Studies:**

Albright retains deep ties to the CSIS, which today counts among its members Alexander Haig, Brent Scowcroft, John Deutch (former director of CIA), Donald Rumsfeld, Henry Kissinger, and many other deep intelligence and defense insiders. Haig is today director of United Technologies Corporation.

➤ **1989: President, Center for National Policy**

Democratic neo-conservative think tank responsible for helping to further institutionalize social decay and the permanent warfare economy of the US. One of the directors of the CNP is democratic financier and premier diamonds merchant Maurice Templesman.

➤ **February 6, 1993: U.S. Permanent Representative to the United Nations**

➤ **August 1995: Chairman: President Clinton's Interagency Council on Women**

Designed partially to legitimize "demonstration" elections manufactured and manipulated by the US state department for corporate and private interests.

MILESTONES: U.S. foreign "policy" under Madeleine Albright 1993-2002

- 1994: Albright helps stall and block all UN interventions and decisions on Rwanda.
 - 1995: Halliburton (Brown & Root) sets up bases in Rwanda
 - 1995: America Mineral Fields move to Hope, Arkansas
 - 1993-2003: Ken Saro-Wiwa executed in Nigeria (1995); genocide in Niger River Delta.
 - 1995: Clinton Administration facilitates MPRI roles in Angola.
 - 1999 Clinton Administration facilitates MPRI role in Nigeria.
 - August, 1996: Zaire war launched by RPF & UPDF
 - September 1996: Clinton announces Africa Crises Response Initiative
 - 1993-2003: IMET expanded; E-IMET and JCET (Joint Combined Exchange and Training) programs begin and covert operations proliferate. ACRI (Africa Crisis Response Initiative) designed and implemented.
 - 1997: Albright tour of Africa
 - 1997: Albright cozies up to Congolese “liberation” leader Laurent Kabila
 - 1998: approves decision and subsequent launch of 68 cruise missiles against supposed “terrorist” training camps in Afghanistan, and the Tomahawk cruise missile attack that destroyed the pharmaceutical plant in Sudan.
 - August 1998: Congo war launched by RPF & UPDF with US military strategic, logistical and tactical support.
 - 1990’s: Angola remains a site of deracination and war
 - 1995-1999: Albright & Susan Rice refuse constructive engagement with Sudan’s National Islamic Front govt, support SPLA John Garang (through Uganda) Note: British newspapers after 9/11 claimed that the NIF government offered US heap of intelligence info on Usama Bin Laden, and even bin Laden himself, prior to 9/11.
 - 1999: Secretary of State Albright leads Lusaka “Peace” Accords in DRC.
 - 1990’s Peddled Corporate Council on Africa (est. 1992).
 - January 2000, Albright negotiated implementation of Plan Colombia (Bogata).
 - March 2000: Lazare Kaplan International (Templesman) signs deal with Revolutionary United Front and Foday Sankoh in Sierra Leone (allied with Charles Taylor); ties to Eyadema business dealings and other US companies in diamonds in Sierra Leone. Note: wife Fatou Sankoh travels on US passport.
 - 1993-2003: Charles Taylor continues to devastate Liberia under destabilizing US Liberia policy.
 - 1993-2002: Administration remains “mute” at best, on human rights atrocities in Togo, Gabon, Central African Republic, Equatorial Guinea and Burkina Faso, while pursuing clandestine capitalist penetration, raw materials extraction, and military consolidation of power through private military companies and covert operations.
 - 1994-2003: Formation of International Criminal tribunals on Rwanda and Yugoslavia – set about to legitimize victors and demonize victims of ongoing US foreign policy of destabilization and depopulation.

 - Widespread institutionalization of death, disease and despair.
